- 5. Sealed bids must be ssubmitted to the Dharche RM Machhikhola by hand before 12:00 hrs of December 20, 2018 (2075/09/05). Late bids will be rejected and not opened. The bids will be opened physically 13:00 hours December 20, 2018 (2075/09/05) in the presence of the bidders' representatives who choose to attend in person at Dharche RM Machhikhola.
- **6.** Bids shall be accompanied by a Bid Security for the amount as specified in the table above in local currency. Bidders are required to submit a separate bid security for each contract for which they submit bids. The bid security guarantee shall confirm to the standard format as specified in the bid document. The bid security guarantee issued only by the commercial bank approved by Nepal Rastra Bank shall be accepted by the Employer.
- 7. Bidders are required to specify the total price of the Bid in the Letter of Bid or the Bid Price in the Bill of Quantities. Failure to specify the total price of the Bid in the Letter of Bid or the Bill of Quantities shall be ground for declaring the bid non responsive.
- **8.** Bids and Bid Security shall be valid for the period as mentioned in the table above.
- **9.** Dharche RM reserves right to accept or reject any or all bids or annul the bidding process and reject all bids without assigning any reason, whatsoever.
- 10. If the last date of pre-bid meeting, purchasing and /or submission falls on a government holiday, then the same time on next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 11. The bidder may bid for any or all of the slices/packages as invited in the IFB. Bidders, bidding for more than one slice/package will so indicate in their bid, together with a statement regarding any discount / cross discounts offered, but the Employer may approve the bid for one or any least cost combination of contracts subject to bidders meeting the qualification. The bidder should meet the qualification criteria separately for each Bid and in aggregate as stated in the Instruction to Bidder.
- 12. Any intimidation, collusion and cartelling during bidding process shall be punishable by law.
